What's In It For You?

Day One: Morning

China business environment: What are the important changes affecting FIEs?

A thorough overview of the current accounting system and business operating environment in China. This session will provide updates on government legislation effecting Foreign Invested Enterprises (FIEs) operating in China, and the issues driving the current regulatory system. We will then lead into the new ASBE by way of an overview and a brief on the major changes.

Day One: Afternoon

New Accounting system: What are the changes affecting your business?

A detailed analysis of the new ASBE, including technical examination of the new accounting standards and major changes effecting FIEs in China (e.g. bad debts provision, depreciation, investments etc). Case studies and real-life examples will be drawn upon to provide practical guidance and solutions so as to comply with the new system.

Day Two: Morning

What changes will your company need to make?

This half-day session will deepen analysis of the changes required for PRC compliance, as well as adjustments required for IAS restatement. Included in this session will be an examination of the new reporting requirements (including notes to the accounts) as required by FIEs, and how the three accounting reports must be presented. We will then provide a practical guide to prepare for the changes and a discussion on how the implementation process should be managed in your company.

Day Two: Afternoon

What changes will your company need to make?

To conclude the seminar, we will examine how the new accounting changes link into the business environment in China including changes to the taxation system, mergers and acquisitions, company restructuring, audits, FOREX controls, transfer pricing, legislative requirements and changes ahead of the WTO entry. This will provide attendees with an overview of the day-to-day issues facing many FIEs in China and how the business environment fits together.
